# Services for Victims of Violence

Violence and abuse come in many forms – from community youth and gun violence to intimate partner violence (IPV), child abuse, sexual assault, elder abuse and mass violence.

#### Did you Know?

- South Carolina has one of the highest homicide rates in the U.S.
- Violence is one of the leading causes of death for children, teens and young adults in the U.S.
- Community gun violence is the leading cause of death for Black male youth and young adults in the U.S.
- 1 in 4 women will experience sexual violence and/or intimate partner violence during her lifetime.
- 1 in 7 men will experience intimate partner violence during his lifetime.
- 1 in 4 children have experienced abuse or neglect at some point in their lives, and 1 in 7 children have experienced abuse in the past year.
- Approximately 1 in 10 Americans 60 years and over have experienced some form of elder abuse.
- Violence increases the risk of disability, mental health problems, substance abuse, chronic pain, experiencing further violence, poor outcomes in school and work as well as poverty.

No one should have to experience violence, abuse or neglect. MUSC wants you to know that we care about your health and safety and encourage you to talk with your health care providers if you are experiencing violence or abuse. People have a variety of needs after experiencing violence to address physical injury, emotional trauma, family support and counseling, legal and financial support, safety planning, transitioning back to work or school, and obtaining basic needs like food and housing. There are many services at MUSC and in the community to help you, your children and your family.

# **MUSC Services**

# MUSC Turning the Tide Violence Intervention Program

Violent injuries can be life changing. MUSC's Turning the Tide Violence Intervention Program (TTVIP) aims to improve the care and recovery of violently injured patients as well as prevent future violence and improve quality of life. We primarily serve patients between the ages of 12 and 30 who have suffered gunshot injuries from community-based violence and are being treated at MUSC Charleston's adult and pediatric trauma centers. We also support other victims of community violence, such as assaults and stabbings, while they are in the hospital, as well as families who have suffered the loss of a loved one to gun violence. Comprehensive services are offered to patients and families who enroll in the program to promote recovery, reduce repeat violence, and improve their safety, health, and social and economic outcomes.

#### Services include:

- Immediate bedside support, mentorship and safety planning
- Conflict resolution
- Care packages and emergency needs assistance
- Needs and risk assessments, goal setting with patients
- Connecting patients to MUSC and community services such as food, housing, education, employment, transportation, health care, mental health, substance misuse counselling, victims' services, homicide survivorship services and other community support.

Specialized violence intervention client advocates are on call 24/7 to coordinate with service providers to make sure patients access and obtain what they need. We meet with patients and families during their hospital stay and stick around for months after, including in-person visits, virtual visits, texts and phone calls to ensure needs are being met and that recovery is going well.

## MUSC Advocacy Program

The MUSC Advocacy Program (MAP) provides 24/7 social work response to patients and families with concerns of intimate partner violence (IPV) and abuse or neglect of children and vulnerable adults. Our program provides coordinated response to MUSC's patients, families and employees experiencing abuse or neglect.

#### Services include:

- Crisis response, support, education and advocacy
- Coordination with the forensic nurse examiner and medical team, including the Child Abuse Pediatric Division
- Coordination with local law enforcement and the Department of Social Services
- Risk assessments, safety planning and linkage with resources and referrals

Please page the on-call MAP Social Worker if you are concerned for a child or a vulnerable adult. They are available to support patients and staff at all MUSC Charleston locations including both hospital locations and the clinics. The team is available onsite Monday – Friday 8:00 a.m. to 5:00 p.m., and they are available on call 24/7. The MUSC operator (843-792-2300) can page the on-call MAP team member at any time.

## SC Safe Seniors

The SC Safe Seniors program offers mental health support to older adult victims of abuse, mistreatment and other traumatic events. Older adults who have experienced something like this may experience anxiety, depression, post-traumatic stress disorder (PTSD), substance abuse or adjustment disorder. SC Safe Seniors provides treatment through in-person and telehealth therapy with a licensed professional counselor. All our services are free, and no insurance is needed. In addition to treatment, we also enhance awareness and identification techniques regarding elder abuse and mistreatment by educating health care providers, senior service providers and the general community through our flagship training, which is offered both in-person and online.

SC Safe Seniors is housed at the MUSC College of Nursing and is funded by the Victims of Crime Act through the SC Office of Attorney General.

## **MUSC Child Abuse Pediatrics**

The MUSC Children's Health child abuse program consists of a team of physicians, clinicians, forensic nurse specialists and specially trained staff who evaluate and care for children experiencing physical abuse, sexual abuse, emotional/psychological abuse, and neglect. Consultations are available at MUSC Health clinics in downtown Charleston as well as MUSC Health outreach clinics, the Dee Norton Lowcountry Children's Center and the Dorchester Children's Center. Our doctors and nurses also work with abused children in the emergency department and continue to care for them during follow up visits. The team provides consultation 24/7.

## MUSC National Crime Victims Research and Treatment Center

The MUSC National Crime Victims Research and Treatment Center (NCVC) offers a variety of specialized, evidence-based assessment, intervention and treatment services to adult and child victims of violent crime and their families, as well as to victims of other forms of traumatic events, such as automobile crashes, house fires, industrial incidents, terrorist attacks and natural disasters. Survivors and those who have been exposed to violent crime, natural disasters or severe incidents can often feel alone, and often need support for mental health needs. For nearly 30 years, NCVC has served victims of rape, physical assault, child and elder abuse, neglect and exploitation, natural disasters, and family members of homicide victims.

# MUSC Trauma Resilience & Recovery Program

The Trauma Resilience and Recovery Program (TRRP) addresses the emotional health needs of patients and their families after traumatic injury. After experiencing injuries, people may experience anxiety, sadness, sleep problems or avoidance of places or situations. Our TRRP health care providers include clinical psychologists that see patients while they are in the hospital, and offer advice and strategies for coping after a traumatic event. If agreeable, a TRRP team member will contact patients 30 days after being discharged from the hospital to conduct a free check-in over the phone to evaluate emotional recovery. If the 30-day check-in suggests that trauma-focused counseling is likely to be helpful, TRRP mental health specialists can provide it either in-person or via video so that patients can get treatment in the privacy and convenience of their home. TRRP can also provide referrals to community mental health centers, if preferred.

# Response to Trauma and Grief

A traumatic event or injury is a threatening, frightening, dangerous and/or violent event that can cause physical and/or emotional harm. These can include serious injuries, illnesses, psychological abuse, witnessing or experience violence or having the sudden loss of a loved one or friend. It is normal to have new feelings and changes after trauma. Sometimes these are positive like stronger relationships and support, appreciation for life, newfound purpose, and personal growth, while others can be distressing including anxiety, depression, difficulty sleeping, fear of people and places, flashbacks, trouble concentrating and disrupted relationships. It is important to know that MUSC and the community have multiple services to help you or a loved one after a traumatic event.

These distressing feelings and experiences can sometimes improve after a few weeks, but if they persist over a month or are severely impacting your mental health, you or your loved one may benefit from emotional support and counseling by a trained professional through the MUSC Trauma Resilience & Recovery Program (TRRP), the MUSC National Crime Victims Center (NCVC) or a mental health professional in the community.

## Some *responses to grief* (loss of a loved one) include:

- Sadness and loneliness
- Resentment and anger
- Fear and anxiety.

Over time these may resolve or fluctuate, or people may find themselves accepting the loss of a loved one. They may also feel connected to the loved one even though they are not here, find comfort in the positive memories, and feel like they are healing. There is not a "normal" path or time period for this process. Sometimes people experience longer grief or complicated grief, especially after losing a loved one to violence.

## Signs of *complicated grief* can include:

- Trouble accepting the death
- Inability trusting others
- Numbness and attachment
- Increased agitation, bitterness or anger
- Feeling life is empty or meaningless
- Believing the future will be hopeless.

While some of these thoughts are normal after experiencing the loss of a loved one, if they are severely impacting your health and mental health, or persisting after a year, counseling services will be helpful. MUSC National Crime Victims Center (NCVC) and other community groups offers survivor counseling services and support groups for survivors of homicide.

# Victim Rights and Services in South Carolina

# SC Crime Victims' Constitutional Rights

To preserve and protect victims' rights to justice and due process regardless of race, sex, age, religion or economic status, victims of crime have the right to:

- Be treated with fairness, respect, and dignity;
- Be free from intimidation or harm throughout the criminal and juvenile justice process;
- Be informed of victims' rights;
- Be reasonably informed of criminal proceedings;
- Be informed if the accused is arrested, released or escapes;
- Confer with the prosecution before the case is heard in court;
- Be present at criminal proceedings where the accused has the right to be present;
- Be heard at proceedings affecting bond, bail, release, pleas or sentencing;
- Have reasonable access to documents relating to the crime before trial;
- Receive restitution from the adult or juvenile offenders; and
- A reasonable, prompt and final conclusion of the case.

These are adapted and condensed from the Constitution of South Carolina, Article I, Section 24.

# **Eligibility for Crime Victim Compensation**

South Carolina has a Crime Victim Compensation Fund to help citizens with costs related to injuries received as a result of a crime. Advocates here at MUSC can help individuals complete the application. The eligibility requirements to receive services from the Department of Crime Victims Compensation (DCVC) are:

- The crime must occur in South Carolina.
- The victim must sustain a direct injury (physical or psychological).
- South Carolina law requires DCVC to consider contributory or illegal behavior when making eligibility determinations.
- The victim/claimant must cooperate with DCVC and law enforcement.
- The crime must be reported within 48 hours (may be waived for good cause).
- The claim must be filed within 180 days (may be waived for good cause).
